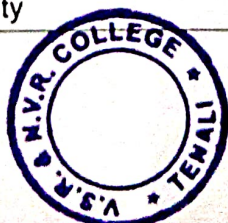

## ANNUAL REPORT: 2024-25

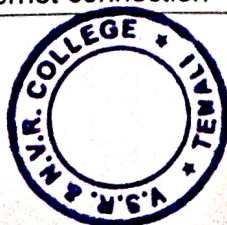
The institution prepares annual reports and shares them with the stakeholders for feedback and further improvement.
